### **Agreement Scope:**

Cooperation and promotion of further mutual interest of Environmental education, Environmental Awareness and Conservation Activity and training in the fields of Environment and community service for Eco friendly Behaviour of the youth of the country of both institutions.

### **Section I**

Government Science College, Maninagar, Ahmedabad, Gujarat State, India and Government Arts College, Maninagar, Ahmedabad , Gujarat State, India mutually agree to cooperate in the following activities:

1. Co-operation for education, research activities and training in the field of Environmental Conservation.
2. Promotion of exchange activities of students, experts, faculty and researchers for the Activities related to Environmental awareness and conservation.
3. Cooperation in awareness activities and social work for Eco friendly Innovative projects of the institute.

4. Mutual sharing of available physical facilities for education, research, in the fields of Environment
5. Cooperation, mutual guidance and sharing of experiences for various activities like Community services, Survey , Research, Eco club activities and NSS activities for Environmental Concerns, Awareness and Conservation.
6. Other mutually agreeable undertakings.

## **Section 2**

Prompt cooperation within the Agreement, exchange of information, harmonization of documents and actions will be done by administrative officials of the Parties within the framework of their areas of responsibility and by authorized representatives of the Parties.

## **Section 3**

Any dispute arising in the course of collaboration, Parties will dispose by means of mutual negotiations. The Agreement is valid for Three years from the date of signing this agreement and can be renewed for further periods by mutual agreement. The terms of the Agreement may be amended at any time by mutual written agreement of both Parties. This Agreement can be terminated by either party upon giving a three months' written notice. This Agreement is written in two copies having equal power for each of the two.


